I solemnly swear that I was born at *West Bromwich, England* on or about the *19<sup>th</sup>* day of *March*, 18*68*; that I emigrated to the United States, sailing on board the *Celtic*, from *Liverpool*, on or about the *10<sup>th</sup>* day of *April*, 18*65*; that I resided *18* years, uninterruptedly, in the United States, from *1885* to *present time*, at *Troy, N. Y.* *about 14 years*; that I was naturalized as a citizen of the United States before the *County* Court of *Rensselaer*, at *Troy, N. Y.* on the *10<sup>th</sup>* day of *October*, 18*90*, as shown by the accompanying Certificate of Naturalization; that I am the IDENTICAL PERSON described in said Certificate; that I am domiciled in the United States, my permanent residence being at *Bridgeport*, in the State of *Conn.*, where I follow the occupation of *act. inspector of Ordnance, U.S.A.* that I am about to go abroad temporarily; and that I intend to return to the United States *in about 1 1/2 to 2 years*, with the purpose of residing and performing the duties of citizenship therein.
